Exposed piping and equipment will be drained. **Cleaning of pool is excluded from this service contract.** (Debris left on the pool floor can cause stains.) ☐ **I understand.**

- Complex systems e.g. In-floor cleaners, water features, etc. that require additional labor will be assessed accordingly. ☐ **I understand.**
- Jobs outside 25-mile radius will be billed extra travel. ☐ **I understand.**
- **REPAIRS ARE NOT A PART OF POOL CLOSING.** Repairs and/or replacement of poor equipment must be authorized by customer and will be invoiced on a separate work order. Return work will be scheduled as quickly as our schedule allows.
- All items must be out and accessible at the time of closing. Any return plugs, skimmer plugs/gizzmo, or other necessary equipment (will be replaced if on the truck) and billed at an additional charge. If we do not have the necessary equipment to close the pool, it will need to be rescheduled through the office. ☐ **I understand.**
- **WINTER COVER MUST BE AVAILABLE.** If not, your pool closing will need to be rescheduled through the office. ☐ **I understand.**

At closing Fiesta Pools will not be responsible for any missing or damaged items of pool equipment stored on Owner's property under their care and keeping over the winter months.
